

ADDENDUM #1
Elephant Bar Habitat Enhancement
February 3rd, 2026

The following clarifications, changes, additions, and/or deletions are hereby made as part of the Contract Documents for the Elephant Bar Habitat Enhancement Project as fully and completely as if the same were fully set forth herein and must be acknowledged in the Proposal.

Clarification: Pg 7, Section 1.2. Proposals will be opened publicly.

Clarification: Pg.11, Section 2.2. Due to federal grant funding being applied to this project, this contract will fall under the Davis-Bacon Act, and NOT Prevailing wage.

Clarification: Pg 10, Section 1.3. Milestone Schedule has been updated and extended to reflect delay in proposal process. ***If you attended the site show on January 27, you are **not** required to attend again. All questions will be recorded from the day and sent out to the previous group. I will provide a list of any new contractors that attend.*

Clarification: Pg 18, Section 4.9 states that “all equipment that will be operated in and adjacent to the stream channel and live water shall use biodegradable lubricants and fluids.” Following SLOPES V recommendations, the biodegradable lubricant and fluid requirement applies ONLY to hydraulic fluid, and equipment operating directly within live water or saturated channels. We expect that other fluids, oils, and lubricants will be properly maintained and sealed to ensure a clean work environment.

Clarification: An engineer's estimate is not available for this project.

Clarification: A bid bond is required (10% of total amount of bid to be submitted at the time the bid is submitted). Performance bonds (100% of total contract amount) and payment bonds (100% of total contract amount) will be required at the time of contracting. **Please use the bid bond form attached to this addendum.*

Clarification: There are no Disadvantaged Business Enterprise (DBE) requirements associated with this project.

Addition: As required by 2 CFR Part 184 - Buy America Preferences for Infrastructure Projects, all iron, steel, manufactured products, and construction materials used in the project are required to be produced in the United States, unless subject to an approved waiver. Preference points will be awarded to bidders certifying in writing that materials to be provided for the project are manufactured in the United States.

Addition: Under ORS 279A.110(4), bidders or proposers are required to certify that they have not discriminated against and will not discriminate against any of these types of businesses when awarding a subcontract (i.e. minority-owned business, woman-owned business, veteran-owned business, or emerging small business).

Clarification: Pg. 10, Section 1.3 states that a contractor could begin in-stream work on July 15, 2026. The current earliest indicated timing for a start is June 15, 2026. It may be possible to start work as early as June 1st, depending on ODFW review, and assuming weather and river conditions allow.

Addition: The following activities, when performed in isolated areas with appropriate environmental controls and no fish access, may occur prior to July 15, 2026. Contractor must receive applicable approvals from ODFW and Contracting Agent prior to any work beginning.

1. Slough excavation and bench grading prior to final breach or tidal connection

2. Excavation encountering groundwater or requiring dewatering
3. Large wood structure installation in isolated work areas
4. Floodplain fill placement and grading
5. Access construction, staging, and environmental control installation

Addition: Pg.33, Section 01560 Part 1.3 Dust Abatement. C. Contractor will mitigate visible dust on haul roads during implementation.

Provided, however, that upon the failure of the PROPOSER to enter into the contract as described above, the PROPOSER shall pay either the difference between the Proposal submitted by PROPOSER and any larger amount which OBLIGEE may in good faith contract to perform the work, or the PENAL SUM, whichever is lesser.
